### Driving Directions

Directions from Miami/Ft. Lauderdale:

- Take I-75 North (west) toward Naples.
- Take Exit 101 - CR 951/Naples (SR 84) (first Exit after Alligator Alley) exit towards Marco Island/Naples.
- Turn Left on Collier Blvd. (SR 951).
- At first intersection (.5 miles) turn right onto Davis Blvd. Stay on Davis Blvd. for approximately 5 miles until the intersection with Airport Pulling Rd. (Home Depot on the corner).
- Turn Left onto Airport Pulling Rd. Stay on Airport Pulling Road for approximately .5 miles.
- At the intersection of Tamiami Trail East (Collier County Government Center on the corner), turn right onto Tamiami Trail.
- Immediately merge to the left hand lane and take your first left.

The Office of Treiser Collins is well signed and will be located on your left hand side at the first left turn cut-through of the median.

#### Directions from Fort Myers:

- Take I-75 South the Exit 105- Golden Gate Exit.
- At the ramp light turn right onto Golden Gate Parkway.
- Follow Golden gate Parkway approximately 1 mile to Airport Pulling Road.
- Turn right on Airport Pulling and proceed South for 2 miles.
- At the intersection of Tamiami Trail East (Collier County Government Center on the corner), turn right onto Tamiami Trail.
- Immediately merge to the left hand lane and take your first left.

The Office of Treiser Collins is well signed and will be located on your left hand side at the first left turn cut-through of the median.

#### Directions from US 41 Tamiami Trail North:

- Follow US 41 South until the Trail turns East at Downtown Naples (5th Avenue South).
- Proceed East approximately 2 miles.

The offices of Treiser Collins will be on your right hand side after Bayshore Drive but before the intersection of US 41 and Airport Pulling Road.
